General Structure of International Statistical Programs

- Data are collected by national statistical institutes, not the international agency
- The international agency promulgates standards and definitions, which are adopted (or not) by the national statistical institutes (e.g., U.S. Census Bureau)
- The international agency prepares compendia of statistical data and reports

The Top-down View

- United Nations (UN)
- World Bank/International Monetary Fund (IMF)
- International Labor Organization (ILO)
- Organization for Economic Cooperation and (OECD)
- Eurostat
- National statistical institutes (e.g., INSEE)

Comparability and Standards

- Must review each source specifically
- In general, OECD, Eurostat data will be quite comparable
- UN data are less comparable due to differences in the quality of the national statistical institutes gathering the data
